

When the same boat is leased or rented to several clients at the same time the charter:

BOATFINDER SPA, Via Colonna, 128, 00077 Monte Compatri (Rm) - P.I. and C.F. 12345678901

requests the signing of this contract to each of the signers of the MULTIPLE CLIENTS PLEASURE CRAFTS CHARTER OR LEASE AGREEMENT with the purpose of informing and obliging the contracting parties to comply with the contractual conditions present in the aforementioned contract, with particular attention to those indicated in point 15 - MULTIPLE CLIENTS CONTRACT. This contract has the function of joining and linking various lease or chartering contracts (up to 4) to allow leasing or chartering of the same boat to several persons or groups.

Specifically, the charterer who by his or her own free choice, out of expediency and without compulsion of any kind, decides to charter the boat by sharing it with other persons or groups of persons, agrees to share the chartered property with other persons, is aware that the boat is not transferred for exclusive use. The customer may not make any complaint to the charterer/lessor about navigational or management problems attributable to the failure of agreement between the occupants. The customer understands that the choice of itinerary is at the discretion of the occupants embarked, nor imposed by the skipper or charter center. It will therefore have to be agreed upon and accepted by all occupants of the vessel. Thus the passengers commits to arranging the itinerary in compliance with the navigation terms of conduct, the safety of the embarked people, third parties, the vessel and the weather conditions. In the event of damage to the craft, part of it, third parties, or extraordinary and onerous activities attributable to the occupants or their management, each passenger with reference to the contract holder(s) shall be held jointly and severally liable and the charter center reserves the right of recourse.

The signers indicated below take on [lease] [charter] the vessel indicated in the CONTRACT OF LEASE AND/OR RENTAL OF PLEASURE CRAFTS stating that they have read the conditions set forth in the superscript and agree to abide by them.

PRIVACY: The personal data requested from the lessee are collected by the charter and processed on computer and/or paper media in order to fulfill the obligations arising from the contract signed by the lessee and will not under any circumstances be transferred to third parties. The charter guarantees the client compliance with the regulations on the processing of personal data governed by Legislative Decree No. 101 of August 10, 2018, which adapts the Personal Data Protection Code (Legislative Decree No. 196 of June 30, 2003) to the provisions of Regulation (EU) 2016/679 - GDPR. The data controller is Boatfinder spa with headquarters in Monte Compatri (RM), 128 Colonna Street. The client, at any time, has the right to withdraw consent to the processing of personal data by written notice to be sent to the charter office or by email. The client declares that he/she has received and read the information in accordance with Article 13 and on his/her rights under Article 7 of Legislative Decree No. 196/2003 (as amended and supplemented) to the right to access his/her data in the manner provided.
